There shall be three financial upgradations under the MACPS, counted from the direct entry grade on completion of 10, 20 and 30 years of service respectively. Financial upgradation under the Scheme will be admissible whenever a person has spent 10 years continuously in the same grade pay. The MACPS is operational with effect from 01.09.2008.

All Pr. CCAs/CCAs/CAs are requested to forward the cases of all the AAOs, who are eligible for grant of financial upgradation upto 30.09.2016 in the enclosed proforma alongwith Service Book, Complete CR Dossiers upto 2014-15 and latest vigilance clearance certificate in the enclosed proforma, by 22.07.2016 positively.
