**Sub :- Non-relieving of AAOs on promotion as PAOs-reg.**

Reference is invited to this office OM No. A-32014/2015/MF.CGA(A)/Gr.B/150 dated 27-04-2016 and Order No. 23/2016 dated 5<sup>th</sup> July, 2016 regarding promotion of AAOs as PAOs. As mentioned therein the concerned AAOs were required to be relieved within 30 days from issuance of the orders after which they are deemed to have been relieved and pay and allowances were not be drawn beyond 30 day time limit.
