- The tenderer shall have to clearly mention in bold letters the name of the work on the top of the sealed envelope containing tender document i.e. Sealed cover should be superscribed "cabling work for EPBAX in GPAO Complex, INA". The tender should preferably be submitted in the printed envelope of the bidder otherwise he shall have to print his rubber seal stamp on the envelope.
- 2. Sealed tenders shall have to be reach in the O/o Accounts Officer (Admn), R. No.807, 'C' Wing, Lok Nayak Bhawan, Khan Market, New Delhi.
- 3. Sealed tenders shall be opened in the O/o Accounts Officer (Admn), New Delhi at 3:30 PM on 29.04.2016 in the presence of the contractors or their authorized representatives, those who choose to remain present at that time.
- 4. Conditional tenders shall not be considered
- 5. The price indicated should include all cartage, taxes etc. for supply of items for cabling work. The items should be branded & good quality.
- 6. Firm should have TIN No., Service Tax No., PAN No. Copy of the same may be enclosed.
- 7. Company should have minimum 5 years' experience in cabling work of telephone/ EPBAX system in Govt. /PSU sectors ( have executed at least 2 work orders of value having 10 Lakhs each in last 3 years). Copy of supply orders may be enclosed.
- 8. The rates should be mentioned in figures as well as in words. Brasing / overwriting should be avoided/duly attested by the tenderer. Taxes, however, should be indicated separately. In case, nothing is mentioned, it will be assumed that all taxes are included in the rates quoted.

- 9. The items shall have to be supplied within the period as specified in the NIT
- 10. The O/o CGA, New Delhi reserves all rights to accept or reject any or all the tenders without assigning any reason.
