OFFICE MEMORANDUM

A pilot project for online processing of non-plan payments through PFMS is running in the PAOs of two Ministries viz. Ministry of Industry and Ministry of Power. For roll out of the system from 1st October, 2015, 64 Delhi based PAOs having 269 NCDDOs from 38 Departments have been identified. Each of these PAOs will be supported by one Key Resource Person (KRP) (list of KRPs enclosed at ANNEXURE I and mapping of PAOs to KRPs at ANNEXURE II). These Key Resource Persons have been identified on the basis of their experience in the field of implementing accounting applications in the Civil Accounts Organization.

2. These KRPs shall be trained further on the various stages involved in the process flow and functions of PFMS to enable them to impart further trainings on PFMS to the PAOs assigned to them and also the respective DDOs. Also, the various steps needed to make PFMS operational in a PAO will be shared with them. Accordingly, a hands-on practical training has been planned for these Key Resource Persons at INGAF as per the following schedule:
