Office Memorandum

Sub : Promotion of AAOs as PAO for the vacancy year 2015-16.

Attention is invited to this office OM No.A.32014/1/2015/MF.CGA(A)/Gr.B/664 dated 30.10.2015 and Transfer/Posting Policy circulated vide OM No.32014/1/2002/MF.CGA(A)/Gr.B/Vol.III/Policy/663 dated 30.10.2015. The options received from officials indicating their choice of preferred station interalia citing reasons for their choice such as medical condition, employment of spouse, and other personal reasons, were placed before the CSB in the meeting held on 26.11.2015.

2. The competent authority has approved the transfer/posting of the AAOs empanelled for the vacancy year 2015-16 as per details shown in Annexure, on the recommendations of CSB.

3. The following provisions of Transfer/Posting policy are reiterated for the information of Appointing Authority:

(i) These transfer/posting orders have been issued after following the due procedure as enumerated in the policy. Therefore no further representation for reconsideration/modification of the order will be entertained by this office and need not be forwarded to this office. Relieving of these officials should not be held up beyond the 30 day time limit on the plea that he/she has represented against the transfer/posting order.

(ii) The officials covered under provisions of para 3(xxii) can seek debarment, in case, the offer made on promotion causes hardship to them within

the 30 day time limit. . The same will be taken into consideration and decision conveyed to them.

(iii) In terms of para 3(xiv) the schedule for the relieving of these officials on promotion is **30 (thirty) days. On expiry of 30 days from the date of issue of this OM they shall be deemed to have been relieved and pay and allowances shall not be drawn beyond the 30 day period.**

(iv) The Min/Depts where these officials are currently employed are required to issue vigilance clearance to the Min/Dept where they have been allocated **within 5 (five) working days.** In case vigilance clearance is not received within 5 (five) working days, the Min/Dept where the official has been allocated shall proceed to issue the appointment order assuming that nothing adverse from vigilance angle exists. However, in case anything adverse from vigilance angle emerges after issue of the appointment order, then, the officials in charge of the Pr.AO responsible for issuing the vigilance clearance shall be held accountable for the delay and liable for Disciplinary proceedings under relevant provisions of CCS(CCA) Rules 1965 and CCS (Conduct) Rules 1964.

(v) Individual promotion orders stipulating conditions of promotion/appointment are being sent to respective Pr.CCA/CCA/CA.
