The National Commission for Protection of Child Rights (NCPDR) has been constituted under Section 3 of the Commissions for Protection of Child Rights (CPCR) Act, 2005 (No.4 of 2006) by Government of India as a Statutory Body for dealing with protection of Child Rights and related matters.

2. In the Commission, we have a post of Accounts Officer in the Group 'B' which falls under Pay Band-2 in the Pay scale of Rs.9,300-34,800/- with Grade Pay of Rs.5400/-. b) having a B.Com degree or equivalent from a recognized university;

c) having a pass certificate in Sub Accounts Service or equivalent examination conducted by any organized accounts Department or the Central Government (desirable); and

d) having successful completion of training in the cash and accounts work in Institute of Secretariat Training and Management or equivalent(desirable).

3. The post of Accounts Officer is an important & responsible post and therefore the Commission requires services of a competent and qualified person to man this post. It is understood that the persons holding the above noted qualifications are available in your organization and who may be willing to be appointed on deputation basis.
