VACANCY CIRCULAR

Indian Council of Medical Research (ICMR), an autonomous organization under the Department of Health Research, Ministry of Health & Family Welfare, Government of India invites applications for filling up **one post of Senior Accounts Officer** in **Pay Band-3 (₹15600-39100) with Grade Pay of ₹6600/-** on deputation basis for a period three years at its Hqrs. Office, New Delhi. Eligibility conditions & experience for the post is as under:-

Eligibility criteria & Experience:

Holding the analogous post in the Grade Pay ₹6600 on regular basis or the post of Accounts Officer in Audit & Accounts Service of Central / States Govt. or Autonomous Organization or PSU organization etc. in Pay Band - 3 (Rs.15600-39100) plus Grade Pay Rs.5400 with five years regular service.
